

RULES OF PARTICIPATION

CONTEST « Cascades of Local Gifts»

1 **ADMISSIBILITY**

- 1.1 The contest « Cascades of Local Gifts » (the "Contest") is held by Cascades Tissue Group, a division of Cascades Canada ULC (the "Contest Organizer" or "Cascades"). It takes place on Internet on 12/02/2024 9 a.m. (ET) to 12/06/2024 11:59 p.m. (ET) (the "Contest Period").
- 1.2 This Contest is open to all residents of the province of Quebec who have reached the age of majority (18 years) at the time of entry. Employees, representatives and agents of the Contest Organizer, any company, corporation, trust or other legal entity controlled by or related to the Contest Organizer, their advertising and promotional agencies, participating stores, suppliers of materials and services related to this Contest, as well as members of their immediate families (brothers, sisters, children, father, mother), their legal or common-law spouses and all persons with whom these employees, representatives and agents are domiciled (regardless of the existence of a family or non-family relationship) are excluded from participation in this Contest.
- **1.3** An e-mail address is required to enter the Contest.

2 HOW TO REGISTER AND PARTICIPATE

- **2.1** No purchase required.

 - 2.2.2.1 "I confirm that I have read and accept the Contest rules of participation."
 - **2.2.2.2** "By clicking this box, I accept the <u>Privacy Policy of Cascades</u> regarding the use of personal information".
 - **2.2.2.3** "I agree to receive electronic communications from Cascades, including offers, coupons, contests, news releases, surveys and VIP information. I understand that I can unsubscribe at any time."
 - **2.2.3** You must click on "Participate" to confirm your registration. Your registration will then be processed.



3 PARTICIPATION ENTRY LIMITS

- **3.1** The participants must comply with the following entry limits, failing which they may be disqualified:
 - **3.1.1** Limit of one (1) registration per person and per e-mail address. To avoid ambiguity, you may only use one (1) e-mail address to enter the Contest.

8 AWARDING PRIZES

- **8.1** To be declared a winner, all selected participants must:
 - 8.1.1 Be reached by e-mail before December 13th, 2024 (ET) at noon and respond to this communication to confirm acceptance of the Prize. In the case of a selection notification e-mail followed by a statement to the effect that the message could not be delivered, the Contest Organizer has sole discretion to disqualify the selected participant(s) and to proceed in accordance with paragraph 8.2 below;
 - **8.1.2** Complete and sign the declaration and release form (the "**Declaration Form**"), stating that he/she has complied with all the conditions set out in these Contest rules of participation and correctly answered the mathematical skill-testing question included on the Declaration Form. The Declaration Form will be sent by e-mail by the Contest Organizer and the selected participant must return it to the Contest Organizer by replying to the e-mail according to the instructions given by the Contest Organizer so that it may be received within five (5) business days of its receipt;



- **8.1.3** Upon request and in a timely manner, provide the Contest Organizer with a photo identification.
- **8.2** Failure to comply with any of the conditions mentioned in these Contest rules of participation or to accept the Prize will result in disqualification of the selected participant. In such a case, the Contest Organizer may, at its sole discretion, cancel the Prize or proceed with a new draw in accordance with these rules until a selected participant for each Prize is declared a winner.
- **8.3** Within two (2) business days of receiving the duly completed and signed Declaration Form, the Contest Organizer will contact the winner to explain how to take possession of the Prize.

9 TERMS & CONDITIONS
